All spaces are assigned by the Farmers' Market Manager or his designee.

To sell at the market during special events, i.e. craft fairs, you must have attended a minimum of *three* previous market days to qualify. Please read 'Farmers' Market Rules & Regulations' on our website for details about product eligibility requirements. The 'Statement of Production' must be signed and included with your application.

Smoking by vendors at the market is only permitted in the designated 'smoking area'.

The market generally starts about one week before Mother's Day.


